### Characteristics

- The depth of etch exposure can be varied
- Four different grades of retarder are available, from a very light etch to a medium etch. Each grade of retarder is colour coded and contains an integral curing agent that will protect and cure the concrete until the washing process is complete.
- When integral colour concrete is used, a two layer construction can be considered for large pavement areas in excess of 125mm thick. The minimum depth of topping is 70mm. Exposed is available in standard colours. Where the intensity and colour of the aggregate at the surface of the exposed aggregate paving is prominent, colours and colour in the cement matrix can be quite subtle as it is mainly the aggregates that are on view.

## Technical Details

### Surface Retarders

- The surface retarder should be applied whilst the concrete surface still has a sheen using a spray at 4 bar pressure.
- There should not be any standing bleed water but the concrete surface must not be allowed to dry.
- It is important to ensure complete coverage of retarder, (4 – 5m<sup>2</sup> per litre) excess retarder is not a problem.
- Protect surface from rain immediately after applying a retarder.

### Pressure Washing

- Pressure washing time after finishing the concrete, will vary depending on weather conditions.
- Use an industrial power washer with a minimum of 120 bar at the spray head.
- Keep the spray head close to the surface of the concrete, cleaning a small area thoroughly at one time.
- Once the complete area has been done in this way, a final overall wash with the nozzle at a distance from the surface should be given to wash away any final residues.

### Sealing

- You've finally installed the decorative concrete masterpiece of your dreams. Maybe it's a pattern-stamped pool deck or patio, an interlocking paver driveway, an acid-stained floor, or an exposed aggregate walkway.
- Protecting and properly maintaining that concrete will keep it looking spectacular for many years to come while extending its service life. And even if the surface begins to show wear after years of exposure to traffic and the environment, you can often restore its original beauty with special cleaning, stain removal, and polishing products.

## Method of Statement

List of material: -

- Checking the surface preparation and site for our work.
- Road base application with compaction, if required.
- Shuttering work with wooden plywood, as per design.
- Application of bonding agent if required.
- Application of welded steel mesh.
- Application of Exposed Aggregate Mix as per approved mix design, Color and aggregate type.
- Waiting until the bleeding water of the concrete leaves from the concrete surface.
- Application of Surface Retarder then trowels smoothly.
- Washing of the surface after 24 hours with a pressure pump.
- Making the control joint approximately after every 3x3 Mtr or as per the design requirement.
- Application of two coats of A-Z Super Sealer.

## Storage & Handling Requirements

- Store and handle materials in accordance with manufacturer's instructions.
- Keep materials in the manufacturer's original, unopened containers and packaging until application.
- Store materials in a clean, dry area indoors.
- Store materials out of direct sunlight.
- Keep materials from freezing.
- Protect materials during storage, handling, and application to prevent contamination or damage.
